PASS / FAIL for Spring 2020

- Reasons to not take a course pass / fail
 - GRO – see next slide
 - Need GPA to increase for any reason- scholarship, graduation requirement, etc.
 - Enrolled in ENGL 102, 108, or 109H – Must receive a B to fulfill mid-career writing assessment. If you do not receive a B, we will discuss what course will have to receive a B in.
- Highlights of FAQ
 - All Classes can be P/F
 - Deadline is May 6, 2020
 - P/F does not calculate in GPA
 - Counts toward program and prerequisite requirements
 - To pass must receive a D or better
 - Academic Distinction or Graduation – includes P/F units but they carry no GPA value

Other Policies for Spring 2020

- **Withdrawal from a course**
 - Complete in UAccess
 - Last Day – April 14, 2020
 - Will I get a refund? No
 - Will this be a W? Yes
- **GRO**
 - GRO courses with C,D,E grade – Can GRO in a future semester
 - Can I GRO a class that I P/F? No
- **If you are currently GRO'ing a course**
 - P/F – complete the requirement but first grade is included in GPA
 - Choose to get grade – Normal GRO applies

 - If you have difficulty enrolling and have completed an application, contact me
- **CHEE 489 and CHEE 481A offered in Spring 2021**
 - If you want one of these courses, take an elective in Fall 2020 instead
 - If you want CHEE 477R or BIOC 462A take in Fall 2020
- **CHEM 480A is a pre-req for CHEE 326 and must be taken in Fall 2020**

 - Replace above units with either SIE 305 or complete a second Tech Elec
